1) HOMEBASE TRANSITIONAL HOUSING: PROVIDED 4,469 SUBSIDIZED/DISCOUNTED HOUSING NIGHTS AND 3,096 MEALS FOR 35 WOMEN AND 1 FAMILY. SUPPORT AND SERVICES PROVIDED TO HELP THEM OBTAIN PERMANENT HOUSING. 74% AGREED THAT ONE BARRIER TO PERMANENT HOUSING WAS REDUCED.
2) FURLOUGH: WORK PROGRAM TO FACILITATE THE SUCCESSFUL TRANSITION FOR SELECTED WOMEN FROM PRISON BACK INTO THE COMMUNITY. THIS PROGRAM, WHICH BECAME PART OF YWCA OAHU IN JULY 2015, PROVIDED 3,843 RESIDENT BED NIGHTS AND 6,312 MEALS TO 27 INDIVIDUAL RESIDENTS. 21 RESIDENTS WORKED THROUGH THE PROGRAM AND WERE RELEASED IN 2020.**
